



Assembly instructions


- 1. Strip to L = X mm length and take off cable jacket.
- 2. Bead pressing screw, pinch ring, seal and distance sleeve to cable.
- 3. Strip insulation of the single wires (length Y mm).
- 4. Crimp contacts to single wires.*
- Press crimped contacts into contact carrier until they snap into place. Then push the carrier into the connector sleeve to block.
- Put locking unit to the thread of the connector sleeve and screw it towards the direction marked with an arrow until it is tight.
- Push sealing ring into the pinch ring to block and fix both by screwing the pressing screw towards the connector sleeve. (recommended torque 2.5 Nm)

Extracting the contacts:

As the contacts are full floating the extraction tool can be inserted with slight pendular movements to block. Afterwards press the extraction button.


